A holder of the certificate:

- engages with all infants and toddlers, parents, colleagues and others in a positive, constructive manner
- observes the behavior of the baby/toddler, individually and in group, reflects on it and adjusts his actions accordingly
- encourages each baby/toddler in his development, assumes his talents and entrepreneurial spirit
- supports the baby/toddler in all his activities
- encourages positive interactions among infants and toddlers and sets boundaries
- recognizes the social-emotional needs of the infant/toddler and responds accordingly
- provides a stimulating, safe, hygienic and healthy play environment for babies and toddlers
- collaborates with parents and recognizes them as primary educators
- collaborates with others as a function of infant/toddler care
- collaborates, provides feedback and makes appointments
- reflects on operations and contributes to improving child care
- supervises infants and toddlers at their arrival and pickup time
- prepares baby and toddler meals, organizes and supervises meal times
- organizes moments of rest and exercise
- cares for the baby/toddler according to his needs

7. Additional information

Entry requirements ¹

To be admitted to the internship and workplace learning, the student must reach the age of 18 in the school year in which the training is started.

For the professional practice of "Child Counselor Babies and Toddlers", possession of the following certificates and/or compliance with the following conditions is required by law:

- Attestation of knowledge of life-saving action with children as stipulated in BVR of February 23, 2001 regarding the conditions of recognition and subsidization of day care centers and services for care families (and amendments)
- Attestation of medical suitability as stipulated in BVR of February 23, 2001 on the conditions of recognition and subsidization of day care centers and services for foster families (and amendments)
- Be at least 18 years of age as stipulated in BVR of February 23, 2001 regarding the conditions of recognition and subsidization of day care centers and services for foster families (and amendments)
- Extract from the criminal register, model 2 as stipulated in BVR of February 23, 2001 regarding the conditions of recognition and subsidization of day care centers and services for foster families (and amendments)
